Subject: Information to District Education Authorities about Board's circular regarding
905 alerting parents to check the affiliation status of school before admission in
13-7-2020 school & action against schools misleading parents/students.

The Central Board of Secondary Education (CBSE) is the premier national Board under the aegis of Ministry of Human Resource Development. The core mandate of CBSE is to conduct Board Examinations and for this purpose, CBSE affiliates schools for conducting Secondary and Senior Secondary Examinations. The affiliation is granted to the schools on fulfilment of mandatory conditions as laid down in the Affiliation Bye-Laws of Board.

In this connection, it has come to the notice of the Board that some of the non affiliated schools whose application is either under process or has been rejected by the Board or they have not applied for Affiliation with the Board, are misleading the parents by posing as CBSE affiliated school for taking admission of students which creates problem to the Board as well as students/parents at later stage at the time of registration of students for Examination.

These school are displaying various display board at school, prominent locations and on their website and showing remarks i.e "to be affiliated to CBSE", "CBSE Pattern", "likely to be affiliated with CBSE," running under the aegis of CBSE etc.

Keeping in view the larger academic interest of the students, the Board has issued a detailed circular No 03/2020 dated 29.02.2020 (Copy enclosed) alerting parents against admission of their ward(s) in non affiliated schools. The copy of circular and Region wise/State wise list of affiliated schools with the Board are available on Board's affiliation website at link www.cbseaff.nic.in.

You are requested to give wide publicity to this circular by conveying the same to all the schools of the district under your jurisdiction so that these schools may not use CBSE name and mislead the parents/students.

It is further requested to take strict action against these schools to safeguard the future of the students & to appraise the action taken in this matter to the Board.
